This profession not only requires skill, knowledge and experience but leadership qualities as well. The person will attend to Flight safety regulatory matters, adoption of standards, if applicable in the local context.. the person should have good decision making abilities, and should be able to decide things on spot when required. The job is of technical nature and therefore certain level of complexity is involved.

SCOPE AND EFFECT OF WORK: Describe the purpose, breath of work performance, and the effect the work has on the work of others or the functions of the organization

The primary purpose of the work is to ensure strict compliance by the airline to national laws, company procedures and international advisory materials and circulars. The aviation environment demands high level of expertise and job constantly expose oneself to high risks. It is a highly stressful profession.

6. <u>INSTRUCTION AND GUIDELINES AVILIABLE:</u>

The person will take instructions from Operations Inspector I and the Management of Department. The person may also receive instruction from Foreign bodies such as ICAO.

The person will be guided by his Inspector's manual, the Civil Aviation Act, the Bhutan Air Navigation Regulations, Joint Aviation Requirements, ICAO Annexes.

The Flight Safety Officer works under the supervision of the Management of the Department. The person needs to interact with lots of airline operational personnel and therefore interpersonal skills will be of good help. The person will also need to keep good relations with people from the manufacturers' operation support Department and other civil aviation authorities.

The Flight Safety Officer is a fully qualified professional shouldering independent responsibility and may also assist in the conduct of Administration and Surveillance functions on an air operator.
